Direct Sales of Commercially Caught Seafood (for Food Hub/ Farmers Market)

We love creating greater direct marketing opportunities for commercial fishers to direct market their products. There are several steps to take in preparation:

1 ADF&G Intent to Operate Permitting

The options for a commercial fisherman to sell their own catch at the farmer's market or through the online food hub are to obtain one of the following Alaska Department of Fish and Game permits regulated under 5 AAC 39.130:

1.1 Catcher-Seller Permit

Catcher-Seller: this is a free permit and is for a commercial fisherman who wants to sell their own unfrozen and unprocessed catch. Commercially caught fish must be in head-on condition although fish may be gutted and gilled; commercially caught shrimp may be headed. A business license may be required (see #4 below). 1.2 Direct-Marketer Permit

Direct-Marketer: this permit costs \$25 and is for a fisherman who wants to have their own catch custom-processed or sell and process their own catch. Contact Shellene Hutter at shellene.hutter@alaska.gov or 907-465-6131 if this is the first time applying for this permit.

There will be additional requirements if a fisherman wants to process the fish themselves because the kitchen would need to be DEC approved and they would have to attend the HAACP course – here is a link to a good resource about this: http://dec.alaska.gov/eh/fss/seafood/Docs/HACCP.pdf

Additionally, as a direct marketer, a fisherman could have the fish custom-processed, for example at Auction Block or Coal Point Seafoods – contact directly to confirm available services, and then the fisherman could sell that product at the farmer's market/food hub.
